# Bp forms new Clinical Leadership Advisory Committee

Alongside will be Mr Matt Gilchrist, a fellow Practice Manager who also part owns a clinic that is a beta tester for Bp Clinical and billing. Mr Gilchrist has some 10 years' experience in the industry and is a prolific poster on Bp user forum.

Rounding out the new members will be Ms Charlotte Hurn, a registered nurse who is currently the NSW State Nurse Coordinator. Ms Hurn possesses an in depth knowledge in monitoring nursing practice and software use support for doctors and nurses.
