While there are some minor technical matters to be resolved and closed off, we have exceeded 90% of our partners now fully tested and working with the new CMS as from June 2017. This allows us during the second half 2017, and into 2018, to commence working through customized data structures and content for our vendor partners and end users across both existing and new health modalities "

Medicines Management 2016, the 42nd SHPA National Conference

MIMS recently exhibited at the Society of Hospital Pharmacists of Australia (SHPA) National Conference held at the Perth Convention Centre. Attended by over 900 delegates from around Australia and a few from overseas, we were treated to an inspiring and stimulating program with the headline of "Our Future In 3D! Discovery, Disruption, Differentiation" and over 170 contributed posters, scientific papers and series of entertaining and thought-provoking speakers. With a constant crowd of delegates at the MIMS stand, many got the opportunity to experience the "Don't Rush to Crush" version 2 in the eMIMS Cloud platform. This updated content provides knowledge to enable healthcare professionals to administer medicines

oral dose forms. Having this information at hand and at the point of care will ensure that patients receive their medicines in a manner that is safe and maintains the efficacy of the medications. There is also advice on optimal preparation methods for medicines, as well as making healthcare professionals aware if any extra precautions are required. Overall the conference was a success and MIMS was able to engage this key group on medication safety, patient safety, enhancing patient experience, mitigating risk and exploring sustainability in the context of rising costs and increased demand. It was also a great time to catch up with pharmaceutical company representatives, researchers, innovators and technology partners who all contribute to hospital pharmacy.

The Australian Digital Health Agency

The Australian Government has created a new digital agency to enhance the use of data and technology which can help people live healthier, happier and more productive lives. Digital health can make a real difference to people's health by giving them greater control and better access to information. Tasked with improving health outcomes for Australians through the delivery of digital healthcare systems and the national digital health strategy for Australia, the Australian Digital Health Agency (the Agency) commenced operations on 1 July 2016. As part of this process, the Agency will take over the activities and resources of the National E-Health Transition Authority, along with the system operation activities of the "My Health Record" (currently managed by the Department of Health). The government said the new agency CEO, Tim Kelsey, will report to a "skills-based board" that is "reflective of the health community", and will focus on setting up the new agency and transitioning activities from the other bodies. Going forward, Tim Kelsey will be responsible for "the strategic leadership, engagement, collaboration, innovation and operations of the national digital health systems". Key tasks for the role will include leading strategic planning, stakeholder engagement and quality of operations; implementing the National Digital Health Strategy; maximising the interoperability of the public and private e-health systems; and ensuring clinical safety in the delivery of the national digital health work program. Within the challenging and fast-paced environment of health technology and growing consumer expectations, MIMS already complements many healthcare functions. MIMS will continue to partner on federal initiatives and work to embrace this new direction of the Australian Digital Health Agency. The Agency's board, selected in consultation with State and Territory Health Ministers, comprises: Mr Jim Birch AM, Chair. Mr Birch has extensive current and past experience on boards across the health sector. Dr Eleanor Chew is a specialist General Practitioner and medical educator, and a member of many health advisory groups, committees and boards. Ms Lyn McGrath is the executive general manager of a large financial institution and has demonstrated extensive consumer knowledge. Dr Bennie Ng is a general manager of a leading healthcare provider. He has previously held advisory roles to the government and was a general manager in the public hospital sector. Dr Elizabeth Deveny has experience in healthcare delivery and innovative uses of technology. She is the Chief Executive Officer of a Primary Health Network.

Professor Johanna Westbrook is currently Professor of Health Informatics at Macquarie University and holds positions on several advisory committees and boards. Ms Stephanie Newell is the consumer member on a number of healthcare councils and has held similar positions particularly around safety and quality standards. Mr Robert Bransby is the chief executive officer and managing director of a private health insurance fund and a director of a number of financial companies. Mr Paul Madden is the Strategic Health Systems and Information Management Special Adviser of the Commonwealth Department of Health. Mr Michael Walsh is the Director-General of Queensland Health. He has managed and delivered digital health systems in state and territory health facilities. Mr Stephen Moo is the Chief Information Officer of the Northern Territory Department of Health and Families. Australian Digital Health Agency, My Health Record and AMT

The Australian Digital Health Agency (the Agency) is a corporate commonwealth entity. It designs and operates national digital health services and operates under three set standards: give consumers more control of their health and care when they wish it; connect and empower healthcare professionals, and promote Australia's global leadership in digital health and innovation.

The Agency is the system operator for the My Health Record (MyHR) and maintains the Australian Medicines Terminology (AMT).

MIMS partners with the Agency to map the AMT to the MIMS medicines database. AMT is a standards-based foundation to support eMM to ensure accurate medicines information exchange between different healthcare systems.

The Agency is providing funding to community pharmacy dispensing software providers through The Community Pharmacy Industry Partnership Offer, to enhance their products to allow viewing and uploading to the MyHR system, and to use the AMT to enhance the quality and interoperability of medicines information. This Partnership Offer requires a dispensing system to include AMT Concepts to identify the dispensed medical products when uploading eHealth dispensing records to MyHR.

This will give pharmacists a safer means to access current and accurate medicine information through their patient's MyHR and patients will be able to see and share more of their medicines information with their carers and other healthcare providers. This functionality will give the foundations to build more sophisticated medicines information, summaries and alerts in local systems, and to attract system-wide benefits. Ultimately, this will contribute to improving medicines safety for consumers, health professionals and the wider community.

MIMS already maps its entire database to the AMT and is working with all its integrated partners to implement the AMT.

Medicines Information in Aged Care


In the past few months, there have been many aged care vendors partnering with MIMS Australia to provide their end-users with current and relevant medicines knowledge at the point of care. There is a growing concern towards the need for non-prescription Nurse Initiated Medications to be checked prior to administration. In keeping with the guidelines from the Australian Commission on Safety and Quality in Health Care's (ACSQH) National Residential Medication Chart User Guide for Nursing and Care Staff, nurses are required to check any previous drug allergies and/or adverse reactions as well as any contraindications for the resident prior to administration. Through the use of MIMS Clinical Decision Support Module Drug-Drug Interactions, nurses and care staff are able to check if there will be any risk of medication misadventure prior to administration at the point of care, both within the clinical application or via cloud-based technologies such as MIMS Online. It is important to confirm, and regularly update, the facilities nurse-initiated medication lists as approved by their local Medication Advisory Committee (MAC). The majority of nurse-initiated medicines are administered in consultation with the medical practitioner. Registered nurses working in a residential aged care facility (RACF) need to be policies and procedures for nurse-initiated medicines. Protocols for nurse-initiated

medicines should include information about the indication(s) for each drug, the dosage, and related contraindications, allergies and adverse drug reactions.

Below is an excerpt from the ACSQH guide to the National Residential Medication Chart and how to best complete the chart. It is always important to remember with paper-based charts that transcription errors and handwriting illegibility can lead to medication and care misadventures for aged care patients. For example, knowing when and how much reflux medication is used by the patient will provide the prescribing physician

with a clearer picture to further optimise the patient's medication when it comes time for review.

MIMS Australia is working with the ACSQH and a number of aged care clinical applications on many fronts to further increase awareness for medication safety and misadventure in the aged care environment. As specialists in medicine knowledge, we have content and expertise to support our aged care partners with their projects to improve patient care, avoid misadventure and quality of life.

MIMS IVS Annual NZ and Australia – Product Innovation:

MIMS is actively planning to increase its IVS online and mobile presence, including a relaunch of IVS Online in NZ and introduction of an IVS Platform for smartphones and tablets in both Australia and NZ. This will

enable veterinarians to access product information at every point during their working day.

In our research conversing with various veterinarians, we established that:

50% of drugs that veterinarians utilise in their practice for domestic pets are human drugs and therefore there is an opportunity for MIMS to integrate MIMS with IVS and facilitate its placement on Veterinarian's desktops through vendor systems.

80% of veterinary practices have "digital office". MIMS will be considering the integration of IVS onto Veterinarians' practice software which will ensure that every veterinarian/nurse in a veterinary clinic/hospital will have their own IVS desktop version.

In the future, MIMS will be considering the introduction of social media platforms across Australia and NZ to facilitate effective communication and appropriate assistance amongst veterinarians in their practice.

eHealthWise and MSIA

eHealthWise

eHealthWise has been in collaboration with the Medical Software Industry Association (MSIA) in response to the Association's members' concerns regarding Medicare's new policy concerning cloud computing and medical software cloud providers. The MSIA have issued a letter to the Minister for Health, The Hon. Greg Hunt and the Minister for Human Services, The Hon. Alan Tudge concerning the DHS's advice to the medical software industry concerning cloud computing

By way of background, the government's cyber security issued advice to medical software cloud providers in November 2016 outlining a compliance path for Notice of Integration (NOI) certification that included new security measures, including Australian Signals Directorate (ASD) compliance

measures such as hosting on ASD certified providers on a dedicated physical server. As a result of this cloud computing directive, many software providers (including eHealthWise) have had their recent Medicare adapter NOI certification frozen until they become ASD compliant.

An additional concern is the cost for medical software cloud providers to move to an ASD compliant cloud service, as only a few of the existing commercial providers offer a dedicated physical server, which is very costly. This concern is compounded by the fact that DHS has recommended specific suppliers, limiting the choices available to cloud providers. We are expectant that this approach will assist in resolving this issue for medical software providers in Australia.
